This policy also applies to all public hearings. Citizens may also submit written requests (outlining their issue) for an item to be considered at a future Council meeting. The Chair may place the item on the agenda under citizen comments; direct staff to assist the citizen; direct the citizen to the proper administrative departments; or take no action.
