ORDINANCE NO. 20-09

**AN ORDINANCE REPEALING CHAPTER 2.73 OF THE MILLCREEK CODE OF
ORDINANCES ENTITLED “LOBBYIST DISCLOSURE”**

WHEREAS, the Millcreek Council (“Council”) met in regular session on March 9, 2020, to consider among other things, repealing Chapter 2.73 of the Millcreek Code of Ordinances entitled “Lobbyist Disclosure”; and

WHEREAS, Chapter 2.73 of the Millcreek Code of Ordinances requires among other things that Lobbyists obtain a license before engaging in lobbying efforts with city officers; and

WHEREAS, the Council find that Chapter 2.73 of the Millcreek Code of Ordinances is unnecessary and imposes an unnecessary burden on staff and lobbyists; and

WHEREAS, after careful consideration the Council has determined that it is in the best interest of the health, safety and welfare of the residents of the City to repeal Chapter 2.73 of the Millcreek Code of Ordinances.

NOW THEREFORE, BE IT ORDAINED by the Council that Chapter 2.73 of the Millcreek Code of Ordinances entitled “Lobbyist Disclosure” be repealed and deleted in its entirety and that the City Attorney and City Recorder are hereby authorized and directed to take such actions as necessary to effectuate the purposes of this ordinance.

This Ordinance assigned no. 20-09, shall take immediate effect as soon as it shall be published or posted as required by law and deposited and recorded in the office of the City’s recorder.
