Chair Silvestrini called the meeting to order.

**1. Presentation of Fiscal Year 2020-21 Community Reinvestment Agency Fund Tentative Budget; Laurie Johnson, HR-Finance Director**

Laurie Johnson said the budget had not changed from the Board's meeting two weeks ago. The budget included a loan from the West Millcreek Community Reinvestment Area (CRA) to the Millcreek Center CRA in the amount of \$721,800. The revenues for both CRAs were just over \$8.2 million. She said the \$721,800 was reflected in the debt interest in the expense budget for the Millcreek Center CRA. She said she would update the tentative budget if new data came in before the final budget was adopted.
