Introduction:

This analysis is intended to provide Millcreek, a Utah Municipality, and the Millcreek City Council with the information required by the Utah Code Section 10-8-2. Appropriations -- Acquisition and disposal of property -- Corporate purpose -- Procedure.

Reason for the Study:

Utah Code § 10-8-2 and case law require a more rigorous review and approval process before the City can provide grants to nonprofit organizations. The process requires that the City complete a Study before the grants are awarded.

Critical Elements of the Study:

In making the Study, the following factors shall be considered:

1. Completion of a Study that addresses the following:
 - a. The benefit the City will receive—tangible or intangible—in return for appropriated funds.
 - b. An analysis of how the appropriation will be used to enhance the safety, health, prosperity, moral wellbeing, peace, order, comfort, or the convenience of Millcreek residents.
 - c. Whether the appropriation is necessary and appropriate to accomplish any of the goals and objectives of the City, such as:
 - i. Removing blight or underdeveloped properties;
 - ii. Increasing the City's tax base;
 - iii. Creating jobs;
 - iv. Retaining jobs, and
 - v. Any other identified public purpose that the appropriation might serve.
 - d. Completion of a financial analysis showing projected financial returns to the City, if any, and the period over which the City will recoup the amount of the appropriation.
2. A finding by the Council that the development will promote the safety, health, prosperity, moral wellbeing, peace, order, comfort, or the convenience of the Millcreek residents shall be adopted by Resolution citing the Study as evidence to support that finding.
3. The final appropriation shall be completed in accordance with the processes outlined in Utah Code Ann. § 10-8-2:

- a. If the appropriation is made as an amendment to the current year fiscal budget, then the appropriation shall be approved pursuant to the process outlined in Utah Code Ann. § 10-8-2(3)(d).
- b. If the appropriation is made as part of a future fiscal year budget, then the appropriation shall be approved during the regular annual budget process.

Millcreek Agreement – Millcreek proposes to make the following monetary appropriations for the Fiscal Year 2020/2021:

- **Millcreek Community Councils**
 - Canyon Rim Shall not exceed: \$6,000
 - East Mill Creek Shall not exceed: \$5,000
 - Mt. Olympus Shall not exceed: \$3,000
 - Millcreek Shall not exceed: \$15,000
- **Events** Shall not exceed: \$100,000
- **Rain Barrel Program** Shall not exceed: \$5,000
- **Millcreek Promise Program** Shall not exceed: \$11,000
- **Federal Land Access Program** Shall not exceed: \$2,000

ANALYSIS:

2 Chapter 2.39.010 of the “Millcreek Municipal Code” states that:

... it is the purpose of the City Council to provide for the encouragement of volunteer services and programs within the City. The City Council recognizes that volunteers are essential to the productivity, efficiency, and cost-effectiveness of the City government. The effective management of volunteer programs is, therefore, a matter of significant importance.

Chapter 2.04.130 of the “Millcreek Municipal Code” further states that:

- A. The (City) Council may establish additional committees as it deems appropriate and may convene committee meetings at any time for the purpose of study, discussion, investigation, formal hearings or inquiries, workshops, training, or presentations by or responses from citizens or other interested persons or groups.
- B. No official action may be taken in committee meetings other than the adoption of non-binding recommendations to the Council.

The stated purposes of the proposed Millcreek, a Utah Municipal Corporation, appropriations are as follows:

- Community Councils shall be encouraged to develop priorities regarding municipal services and facilities for its community district. These recommendations should be communicated in writing to the city council on an annual basis for use in policy development and in the budget process. Community councils are encouraged to arrive at such recommendations pursuant to duly held and well-publicized public hearings in

each community district.

- Community Councils are encouraged to make recommendations concerning such applications to the City planning commission.
- The Millcreek City Council may budget monies annually for the community councils which will be spent for administrative costs, including, but not limited to, legal notices, elections, newsletters, computers and software, other office equipment, dues to the association of community councils, city-sponsored community events and community council outreach activities or events, postage, stationery, and duplication costs. Funding will be provided pursuant to budgeted amounts and upon the direction of the city council.
- Utah Venture Outdoors, Inc. plan and execute Millcreek sponsored community-building special events that include a Friday night festival series, a Halloween event known as Millfreaks and the Millcreek Community Theatre. Millcreek is working to integrate active outdoor activities into their economic development arsenal to achieve a wide range of direct and indirect financial goals. The Festival Series events remaining in 2020 have been modified to comply with COVID-19 requirements including virtual events, drive by car shows and drive in movies. The Festival Series will be revised moving into summer 2021 based on restrictions in place at that time.

These events are intended to assist Millcreek in the following ways:

- Supporting Millcreek economic and cultural resource development by generating economic vitality through, crafts, and cultural attractions;
 - Encouraging Millcreek residents to participate in healthy outdoor recreation that is available close to the community;
 - Helping to improve Millcreek quality of life, expand Millcreek businesses and tax revenue base, and create a positive community image; and
 - Making Millcreek more attractive to highly desirable, knowledge-based employees, thus stimulating new forms of knowledge-intensive production to flourish.
- Rain Barrel Program – Will partner with Utah Rivers Council to reduce water consumption by providing subsidized water barrels for Millcreek residents. The Rain Barrels will assist Millcreek in the following ways:
 - A rain barrel is a container that captures and stores rainwater draining from your roof. Barrels usually range from 50 to 80 gallons and have a spigot for filling watering cans and a connection for a soaker hose;
 - Rain barrels save homeowners money on their water bills. Garden and lawn irrigation accounts for 40 percent of residential water use during the summer, according to the U.S. Environmental Protection Agency. By using rain barrels, homeowners can save 1,300 gallons of water during the growing season. Rain barrels provide a free water source for irrigation and ease reliance on the City's water supply; and

- Rain barrels help reduce the flow of storm runoff. When it rains, runoff picks up soil, fertilizer, oil, pesticides, and other contaminants from hard surfaces and landscapes. Rain barrels capture water that would have swept over a paved surface or lawn, thereby minimizing runoff pollutants.
- Millcreek Promise Program - Access to the internet is essential to residents seeking employment or applying for services during the COVID-19 pandemic.
 - The Granite School District has provided data that supports the need for internet access for approximately 800 Millcreek households.
 - Additionally, the Utah State Department of Multi-Cultural Affairs has identified this need. Millcreek is assisting by soliciting donations that will be used to purchase six months of discounted internet service for around 200 families through Comcast.
 - Millcreek is soliciting donations to assist some of our underserved families to provide internet service through Comcast.
 - The City will be collecting the donations and purchasing the discounted services.
- Federal Highways Federal Land Access Program (FLAP) grant.
 - The initial payment is for Millcreek's share of a short-listed Salt Lake County - Millcreek Grant Application for road and parking improvements in Millcreek Canyon.
 - Millcreek is a co-sponsor because the scope of the project includes the entire canyon all the way down to Wasatch Blvd, which is in Millcreek.
 - The \$2,000 is Millcreek's share of a required initial \$10,000 payment to support a required Federal Highways site visit.
 - Millcreek Canyon provides significant value to Millcreek residents and that the planned improvements are targeted at improving the safety along the road for vehicles and bikes as well as moving vehicles off the streambanks into appropriate parking locations to improve water quality.

The municipality of Millcreek's purpose for the above-listed appropriations, will be to enhance the safety, health, prosperity, moral wellbeing, peace, order, comfort, or convenience of the inhabitants of the municipality; and the appropriations are necessary and appropriate to accomplish the reasonable goals and objectives of Millcreek, a Utah Municipal Corporation, in the areas of economic development, job creation, affordable housing, blight elimination, job preservation, the preservation of historic structures and property, and any other public purpose.

Conclusion and Required Finding:

The appropriations are necessary and appropriate to accomplish the public purposes of Millcreek, a Utah Municipal Corporation, in the areas of economic development, job creation, job preservation, to enhance the safety, health, prosperity, moral wellbeing, peace, order, comfort, or the convenience of the inhabitants of Millcreek. Therefore, Millcreek will receive an adequate return for any appropriation of money or resources.
