

**MILLCREEK, UTAH**  
**ORDINANCE NO. 21-20**

**AN ORDINANCE CANCELLING ALL CURRENT DECLARATIONS OF A LOCAL STATE OF EMERGENCY**

**WHEREAS**, the Millcreek Council (“Council”) met in regular session on May 24, 2021 to consider cancelling all current declarations of a local state of emergency; and

**WHEREAS**, a local emergency existed because of the global outbreak of COVID-19 and the Mayor issued Millcreek State of Local Emergency Directive No. 1 of 2020 on March 13, 2020, Millcreek State of Local Emergency Directive No. 2 of 2020 on March 16, 2020, Millcreek State of Local Emergency Directive No. 3 of 2020 on March 17, 2020, Millcreek State of Local Emergency Directive No. 4 of 2020 on March 30, 2020, Millcreek Emergency Proclamation No.1 of 2020 Proclamation Declaring a Local of Emergency on March 12, 2020, as ratified by the Council; and a local emergency because of a severe windstorm the Mayor issued Millcreek Emergency Proclamation No. 2 of 2020 Proclamation Declaring a Local of Emergency on September 9, 2020, as ratified by the Council (collectively “Declarations of a Local State of Emergency “); and

**WHEREAS**, the Council deemed that the local emergency existed because of the global outbreak of COVID-19 and the windstorm have dissipated to a point that cancelling all Declarations of a Local State of Emergency is in the best interest of the health, safety and welfare of the residents of Millcreek; and

**NOW, THEREFORE, BE IT ORDAINED** by the Council that the Declarations of a Local State of Emergency are hereby cancelled and have no further force or effect.

This Ordinance assigned no. 21-20, shall take effect immediately.
