1. Stay Safe, Stay Home Directive Discussion

Mayor Silvestrini said Council Member Uipi was present at City Hall and Council Members Catten, Marchant, and Jackson were participating in the meeting electronically. The purpose of calling the meeting was to recap staff discussion held prior in the morning and to discuss the County's stay at home order that was issued yesterday. The mandatory order required everybody in Salt Lake County to stay home unless they had a need to go out for necessary matters. The order also required the closure of nonessential businesses. The Mayor encouraged any business owners to review the emergency order on the City's website. He said the order was needed because people were not adhering to the guidelines, so recreational sports at the park and play dates for kids would have to stop. He reported that half of the people hospitalized with the virus were under the age of 30. Mayor Silvestrini said he had given direction to Unified Police Department to enforce the County's directive and those found violating it would be first given a warning, for a second violation they would be guilty of a Class B misdemeanor, then the third violation they would be guilty of a Class A misdemeanor. He said City Hall would remain open

though he encouraged the public to make an appointment because most of the City's staff was working from home. There was a skeleton crew at City Hall. He said the City's Department Directors had a meeting that morning and were constantly evaluating what City Hall did and how to best provide services to the public. Field workers were using their vehicles as their offices. Code enforcement was being more lenient but was still in force. Public safety was still on duty and the non-emergency phone number where they could be reached was 801-743-7000. He said there would be an electronic meeting that night about Neffs Lane. Due to the pandemic, there had been 4 fatalities in Utah. He had heard reports that St. Mark's Hospital was not overburdened at that time.

Council Member Uipi asked if city employees had a travel letter to authorize their work movement. Mayor Silvestrini said staff was using city vehicles so he did not feel it would be an issue yet. Council Member Marchant said the County issued a red, yellow, and green summary on businesses that should be included the City's e-newsletter. Rita Lund said the summary was on the City's website and social media. Mayor Silvestrini said he would keep the Council up to date with any recent developments.

ADJOURNED: Council Member Uipi moved to adjourn the meeting at 10:36 a.m. Council Member Jackson seconded. Mayor Silvestrini called for the vote. All Council Members voted yes. The motion passed unanimously.
