**1. Public Hearing on Fiscal Year 2020-21 Community Reinvestment Agency Fund
Tentative Budget**

Mike Winder said there had not been any changes since the budget was last presented to the Board.

Board Member Catten moved to open the public hearing. Board Member Jackson seconded. Chair Silvestrini called for the vote. All Board Members voted yes. The motion passed unanimously.

While waiting for online public comment, Chair Silvestrini said he had been working with city staff on an administrative parking enforcement process. It would allow a hearing officer to do a ticket appeal process and code enforcement officers would be able to issue tickets. He said the 2019 H.B. 411 Community Renewable Energy Act process meetings had slowed down because

of the pandemic. He said the Governance Committee for H.B. 411 were coming up with a weighted vote system that offered protection to smaller entities.
