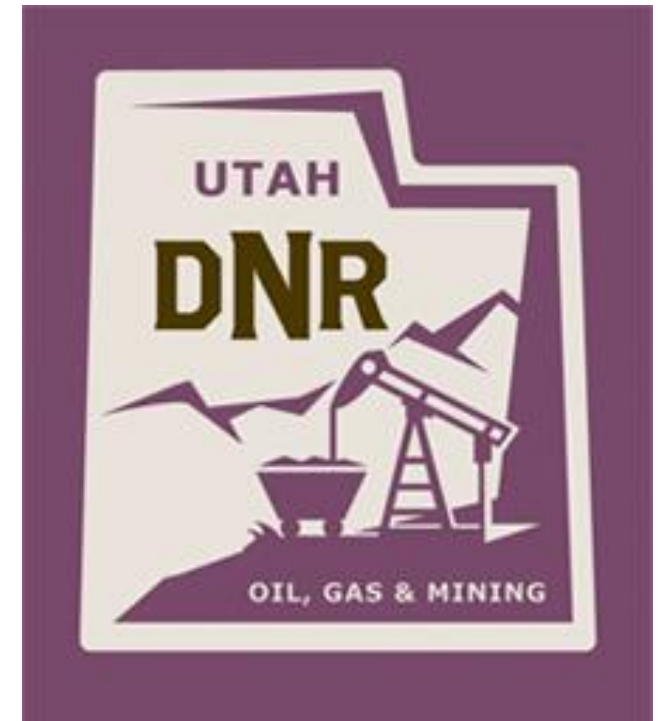

# Salt Lake County Upcoming Meetings

## Amending the Canyon Ordinance Related to Mineral Extraction

Salt Lake County Council voted to begin the process to amend an ordinance to prohibit mineral extraction in forestry and recreation zones. Before adopting this change a series of meetings and public engagement opportunities will take place.

# GRAMA Requested Records

- **September 20, 2010** – Utah Division of Air Quality (DAQ) issues Kilgore Companies, LLC (Kilgore) a Compliance Advisory
- **January 5, 2011** – Kilgore sends DAQ **Fugitive Dust Control Plan Amendment #1** in response to DAQ's Compliance Advisory dated September 20, 2010
- **January 26, 2011** – DAQ issues Kilgore a **Compliance Advisory**
- **April 6, 2016** – DAQ records indicate 2014 inventory not received from Kilgore
- **August 8, 2018** – DAQ issues Kilgore a **Compliance Advisory**
- **October 3, 2018** – DAQ issues Kilgore a **Compliance Advisory**
- **November 2, 2018** – DAQ receives signed **Early Settlement Agreement** and payment of **\$1,414** from Kilgore
- **June 14, 2021** – DAQ issues Memorandum regarding **Full Compliance Evaluation** inspection conducted by DAQ on June 9, 2021. **Kilgore found to be in full compliance.**
